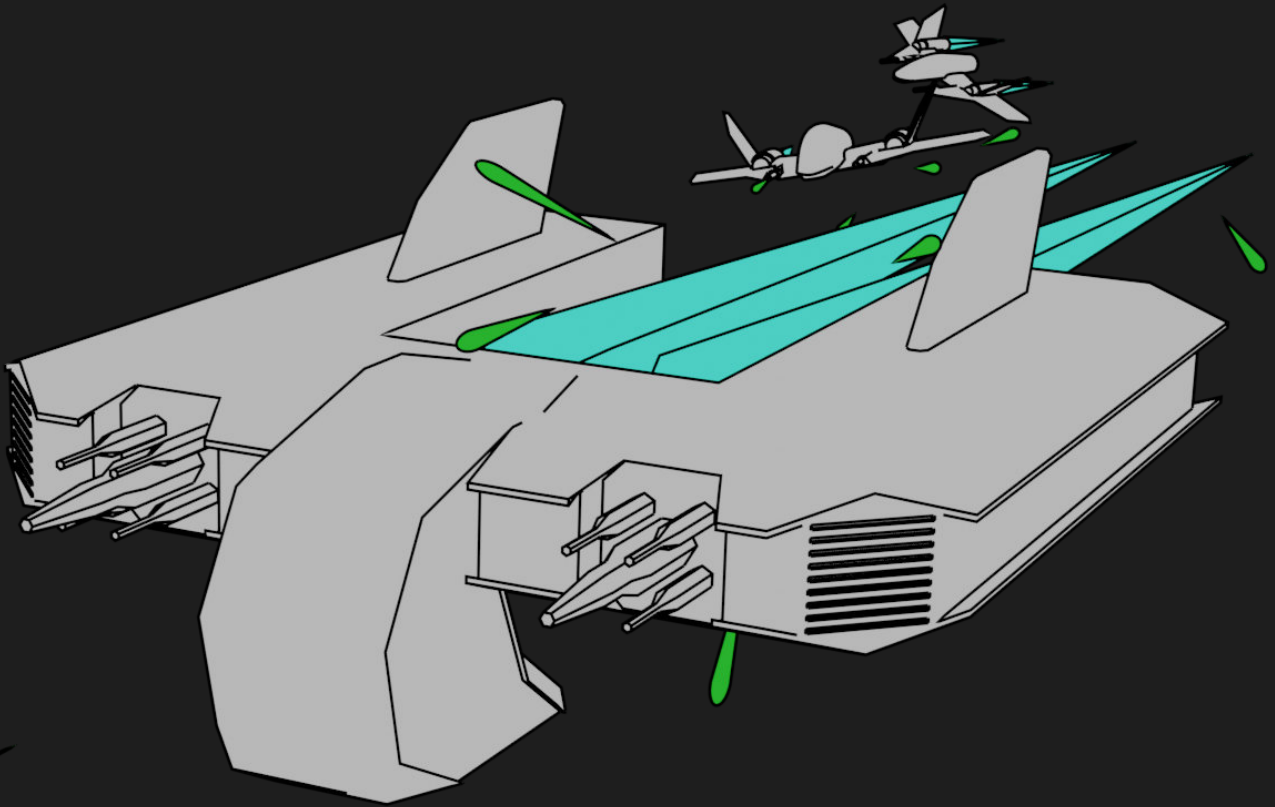

TERMS AND CONDITIONS

BY ANGEL DICE GAMES

SECTION 1 DEFINITIONS

In this agreement:

“Digital content” refers to any and all images, text, artwork and documents available on this website.

“Physical content” refers to any non-digital goods or services provided by Angel Dice Games, including but not limited to: Physical Rule Books, Merchandise and Printed character sheets.

“ADG Content” refers to all Digital content and Physical Content.

“Artwork” refers to any and all images available or embedded on this website or any documents downloaded from this website.

“Documents” refers to any file available for download or display on this website.

“Customer” and “End user” both refer to any and all parties not directly affiliated with Angel Dice Games who download or view any Digital content.

“This website” refers to <http://starsandlasers.com> and all sub domains, except where explicitly stated.

“Table of Players” refers to a group of 10 or less people gathered for the purposes of playing a game created or distributed by Angel Dice Games

“Character sheet” refers to both physical or digital versions of the Starships and Laserguns character sheet and NPC sheet.

“Test content” refers to any content that contains a test content watermark in any form as shown in Figure 1, or any previous versions of content.

“Preview content” refers to any content that contains a preview content watermark in any form as shown in Figure 2.

Parties defined as being “affiliated with Angel Dice Games” are any parties or persons which are employed by, or hold a managerial position at Angel Dice Games. These parties or persons may also be referred to as “Angel Dice Games staff”.

SECTION 2

USAGE RIGHTS

Angel Dice Games retains all rights not expressly granted here in, to all ADG Content on this website except where stated otherwise in another contract signed by parties affiliated with Angel Dice Games.

Angel Dice Games hereby grants to the End user, a perpetual (unless validly terminated in accordance with the terms of this Agreement) non-exclusive, non-transferable single user licence to use the Digital content or Physical content in accordance with this agreement. Under this license, the end user may:

- View or display the ADG Content in a non-commercial setting so long as the End user does not receive goods, services or monetary compensation for doing so.
- Use, modify, reproduce, or transmit any Character sheet document, so long as the End user does not receive goods, services or monetary compensation for doing so.
- Except as expressly permitted by this Agreement, or another agreement signed by Angel Dice Games or affiliated parties, the End user may not transmit, sub-licence, copy, publish, print, or resell, nor permit others to transmit, sub-licence, copy, publish, print, or resell, any ADG Content either on its own, in part, or as part of other content (including third party online content aggregators or databases that are accessible either free of charge or for a transactional or subscription charge), whether in print or digital form.
- Use the ADG Content for the creation and playing of tabletop game session, and allow any Table of Players among which they are playing to view and use the ADG Content for this purpose.
- Create and distribute any video, podcast, stream or other digital media that references and utilizes the ADG content so long as the ADG content is not displayed or is displayed in a transformative manner or for the purposes of commentary. The ADG content may be displayed in any manner that complies with USA and UK Fair use copyright laws.

SECTION 3

CONTRACT CHANGES

Angel Dice Games reserves the right to make amendments to this contract at any time at the sole discretion of Angel Dice Games. These contractual changes may be made without prior warning. The End User is only subject to these changes 30 days after the changes have been made. The End User is also subject to these changes upon such time as they View on this website, Download or Purchase any ADG Content created by, provided by or affiliated with Angel Dice Games before the 30 day period has expired.

SECTION 4 CONTENT CREATION

Content created by any party not affiliated with Angel Dice Games, that is created using rules, lore or holds any affiliation to any Intellectual Property owned by or licensed to Angel Dice Games, remains the exclusive property of the content creator under the provision that the content creator grants a perpetual, non-exclusive license to use, modify, reproduce and transmit this content in any way Angel Dice Games sees fit.
